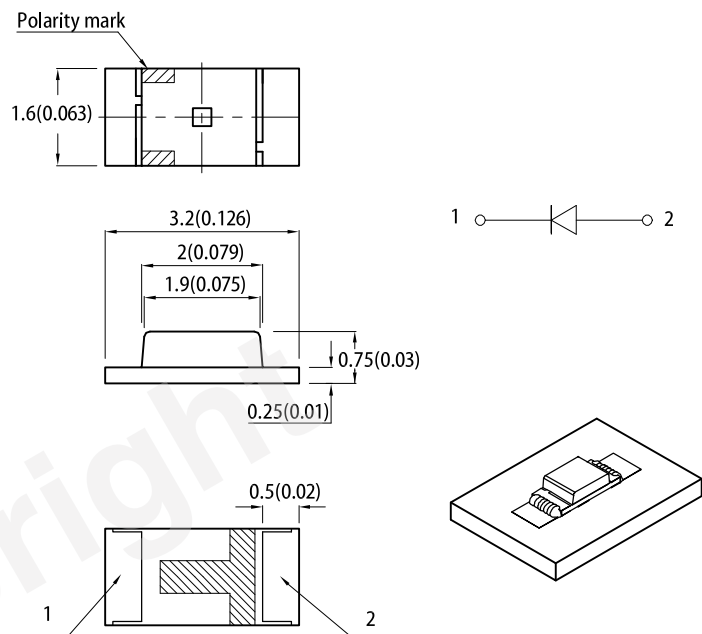

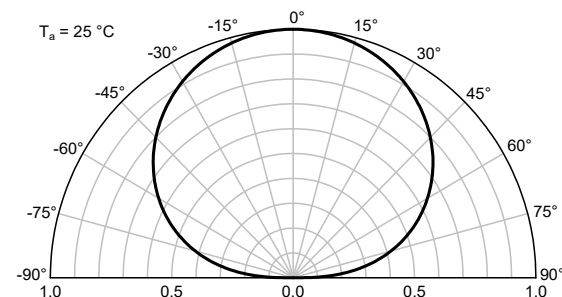

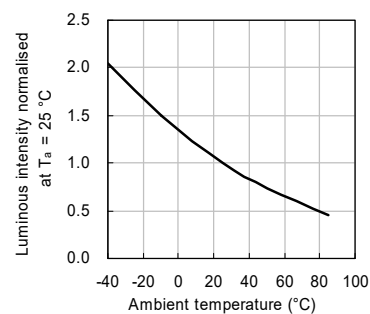

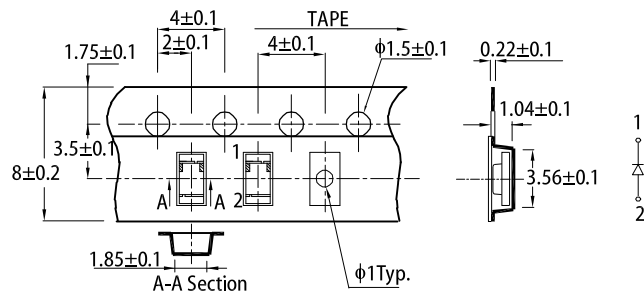
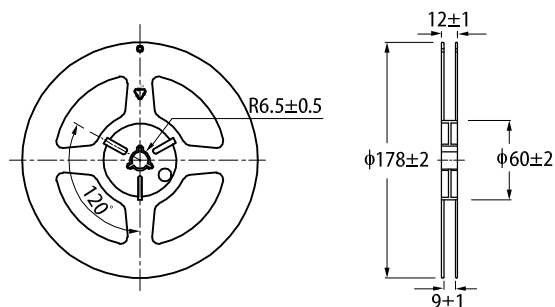
RELATIVE INTENSITY vs. WAVELENGTH



Luminous Intensity vs. Ambient Temperature

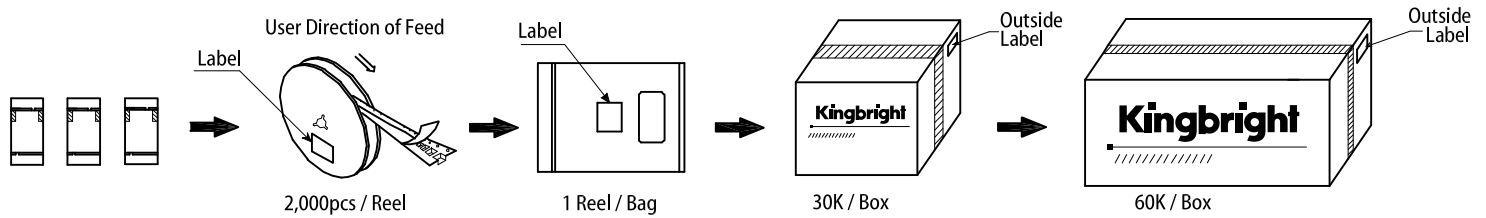
